From the Treasurer

All documentation has been completed and submitted for the process of incorporation. This required us to insure against public liability for \$5 million and, as I foreshadowed at the AGM, to alter the Constitution. This alteration has been kept to a minimum, and involves the addition of only one clause. This clause (VII) simply says that anything not covered in our present constitution will be dealt with under the Rules published by the NSW Department of Fair Trading. Copies of these rules are readily available at branches of the Department. After an exhausting (if not exhaustive) search through these rules, I could find little that I think ALS would actively object to, so will move at the AGM in Perth that the constitutional change be endorsed, if there are no other suggestions in the meantime. After that the matter goes on to the Department of Fair Trading for their decision.

Membership payments for 1999 have been drifting in fairly slowly, perhaps due to the fee increase. Members are reminded that the discount of \$5 on all fees will apply until April 1st, so you are urged to renew your membership before then. If you wish to pay back-fees for 1998, please remember that it will cost you only \$35, not \$50. Unfortunately, people who have not paid for 1998 (i.e. are listed as 1997 on newsletter and/or AJL labels) will have to be removed from the membership list if payment is not forthcoming by April 1st.

Constitution of the Australian Linguistic Society

(established 1957, amended 1979, 1998)

I. The Society shall be known as the Australian Linguistic Society. (herein called the Society.)

II. Objects:

1. To further interest in and support for linguistic research and teaching in Australia.
2. To organise an annual meeting and visits of local and overseas speakers.
3. To publish a journal of international standing.
4. To organise an international congress of linguists when appropriate.

III Membership:

1. There shall be four classes of membership: regular, joint, concessional and honorary. Any person or institution may become a regular member by vote of the Executive Committee and payment of dues.
2. Joint membership is available to couples who are accepted as such by the Executive Committee and who pay the dues set for joint membership. A joint membership shall be treated as a single membership with respect to receiving publications and other communications of the Society, but as two individual memberships for all other purposes.
3. Concessional membership is available to full-time students and to persons granted the concessional rate by the executive committee.
4. Honorary membership will be granted by vote of the annual general meeting to recognise outstanding achievement.
5. Dues shall be determined by vote of the Annual General Meeting.
6. The financial year of the Society shall be the calendar year. On or before 31st March of each year, each regular, joint and concessional member shall pay dues to the Treasurer. There shall be a late fee to be determined by vote of the Annual General Meeting in case dues are paid after 31st March. Unfinancial members shall forfeit their membership rights. Members who are unfinancial for more than one year shall be removed from the membership roll. Only financial members may vote and hold office in the Society. Only financial members may offer papers for presentation at meetings of the Society.

IV. Officers:

1. The Officers of the Society shall be a President, three Vice-Presidents, a Treasurer, a Secretary, an Associate Secretary, and the Editor of the Journal.
2. The officers shall be elected by secret ballot at an Annual General Meeting of the Society, to take office at the conclusion of that Meeting.
3. The terms of office for officers other than the Editor of the Journal shall run for two Annual General Meetings. The President, two Vice-Presidents and Secretary shall be elected in even numbered years, beginning 1980. One Vice-President, Treasurer and Associate Secretary shall be elected in odd numbered years, beginning 1979. The Editor shall be elected in 1979 for six years and thereafter for a term of five years.
4. The Executive Committee shall be composed of the above officers. Executive Committee meetings may be held as required and are open for observation to all members of the Society and to designated observers from affiliated societies. Postal votes of the Executive Committee may be conducted by the Secretary as required.
5. The Executive Committee may appoint one of the Vice-Presidents to deputise for the President or other officer in his absence. If an Annual General Meeting is not scheduled within six months, vacancies (other than a Vice-Presidency) shall be filled by nomination by the Executive and postal ballot of members, for the remaining term of the office.

V. Meetings.

1. There shall be an Annual General Meeting of the Society. The President or his deputy shall chair the Meeting. A quorum shall consist of no less than twenty-five members.
2. a. Decisions at the Annual General Meeting shall be by simple majority of those present.
b. The President shall have a casting vote except at an election to the Presidency in which he is a candidate.
c. On the request of six members, voting on decisions other than election of officers shall be by secret ballot.
d. At elections for an officer, a person

nominated may not vote for an office for which s/he is a candidate.

3. The executive committee shall appoint a Conference Committee to arrange each meeting .

4. The Conference Committee shall review abstracts of papers offered for presentation at the meeting; their decisions concerning acceptance of such papers shall be final.

VI. Publications:

1. The Editor of the Journal shall be responsible for the editorial content and format of the Journal and his/her decision shall be final. The Editor, in consultation with the rest of the Executive Committee, may appoint the Editorial Board.

2. The Associate Secretary shall be responsible for the newsletter.

3. The Journal and the newsletter shall be sent to all financial members of the Society.

VII. For all other matters, the Rules of the Society shall be the Model Rules for the incorporation of Associations, according to the Association Incorporation Act, 1984 – Regulation 1994, Clause 8, of the NSW Department of Fair Trading.

VIII. Amendments:

1. This constitution may be amended at an Annual General Meeting of the Society.

2. An Amendment shall be submitted in writing to the Secretary, signed by at least six members of the Society.

3. An Amendment shall be voted on immediately prior to the election of officers at an Annual General Meeting.

A workshop will be held on Saturday 6th March in the Transient Building, University of Sydney, to look at software for linguistic fieldwork, including annotation, linking text and sound, dictionary interfaces and the use of geographical information (Mapinfo). News from the Research Centre for Linguistic Typology

New staff member Ulrike Zeshan, from the University of Cologne, has been appointed Research Associate for twelve months from April 1999. Ulrike has worked on Indo-Pakistani sign language and the typology of sign languages. Her work will add an exciting new dimension to the Centre's academic endeavours, and we look forward very much to welcoming Ulrike and her family to Canberra.

Visitors During 1999 the RCLT will again host visits from a number of distinguished international linguists. Professor Masayoshi (Matt) Shibatani from Kobe University arrived in Canberra in December to take up a three-month Visiting Fellowship at the Centre. Visits by a number of scholars who specialise in African linguistics are also planned: in March we will welcome Professor Paul Newman from Indiana University to the RCLT for six weeks, Professor Mauro Tosco from the Istituto Universitario Orientale in Napoli, Italy, will arrive for a six-month visit in May, and Professor Hans-Jürgen Sasse from the University of Cologne will take up a Visiting Fellowship for four months commencing in June, during which time he will also teach a typology course for the Linguistics Department on the Theoretical Problems of Polysynthesis.

Publications A number of important publications are now in press. These include Sasha Aikhenvald's major monograph *Classifiers: A Typology Of Noun Categorisation Devices* which is being published by Oxford UP (and should be available by the end of the year), a volume of papers selected from our 1997 Workshop, entitled *Changing Valency: Case Studies In Transitivity*, and a multi-authored volume on *The Amazonian Languages*, edited by Sasha Aikhenvald and Bob Dixon, both of which will be published by Cambridge UP.

News from LiSC

The Language in the School Curriculum (LiSC) project, which has been in operation since the end of 1996, is a national project of the Australian Linguistic Society (ALS) and the Australian Academy of the Humanities (AAH). Its primary goal is to increase awareness and understanding of English Language and language in general in the school curriculum. Funding for 1999 has been sought from DETYA, through the Australian Academy of the Humanities, in the form of a Special Projects Grant. However, due to delays within DETYA, the outcome of the grant application is still unknown and new developments have been put on hold until the result is known.

Ongoing projects such as the Language and Literacy Content Area Team are continuing though. This team is linked to the Early Language and Literacy Project which is a joint partnership between LiSC and the Victorian Board of Studies. The goal of this project is to develop and produce a resource book, *Language Knowledge for Early Literacy: A Handbook for Teachers*. Doug Absalom is the writer for the project. Obituary

We regret to announce the death of Mrs Kathleen Trimmer, one of the very few native speakers of Australian indigenous languages who worked as a linguist, and a friend and former colleague of a number of ALS members.

Mrs Trimmer's father's language was Ngatju, but she spoke Wangkatha, as she had grown up at Mount Margaret Mission. She studied linguistics at Batchelor, and was a mentor to other students there. In the mid-1980s she worked at the Institute of Applied Aboriginal Studies (Mount Lawley College Campus), supporting Nyungar language work, while continuing to work on her Wangkatha material. She was a devoted prison visitor and did some language work in gaol.

When Wangkanyi Ngurra Tjurta, the Goldfields Language Centre, was set up in Kalgoorlie, she started working there as the linguist. She was the inspiration of the Language Centre. There, she concentrated most of her linguistic work on Wangkatha, composing stories and poems, doing translations, preparing language-learning material and dictionary material. The demands on, and expectations of, an Aboriginal linguist are exceedingly high. But, as those of us who worked or went to conferences with her know, she met them with courage, grace, passion, good humour and joking. We will miss her.
